### Chairman's Message

Wow, how quickly time passes! It is hard to believe that 2016 is now behind us and that we are into 2017 already. The year 2016 was a year of much change and improvement within the township, and I personally am looking forward to continuing that momentum all the way through 2017 and well beyond. So, with that being said, let me take a moment and update everyone on several topics regarding entities within the township where I am currently very active.

We have recently completed a full audit of the township's financials via the use of a certified public accountant, Horner, Wible & Terek. The results of this audit mandated that the township update its accounting practices and modernize our accounting software. By switching to the use of Microsoft QuickBooks we now can track both revenues and expenses in real-time and are also able to record all budget related activity in a way that is preferred by the Commonwealth of PA.

We have also started to devote a lot of time and effort to getting the township into compliance with the newly unfunded mandate of the PA DEP's MS4 program. This program is requiring all municipalities to achieve and maintain compliance with all rules and regulations associated with stormwater handling and disbursement. This includes periodic testing of all stormwater outfalls within the township to make sure our stormwater is not contaminated when it is being discharged.

The Township Road Department also has been busy. In addition to general repairs and resurfacing work, time has also been spent repairing and reopening roads that have been closed for an extended period of time. The Township also purchased a street sweeper and a utility bucket truck to replace the previous one.

Finally, I would like to welcome our new ordinance officer, Bill Hause, to the township office. We are looking forward to him continuing to make sure all citizens of the township are following the rules and regulations that we have put in place to assure our community is as clean and safe as possible.

Thank you for giving me the honor and privilege of being able to serve our community over the past year. I am looking forward to continued and expanded successes going forward.

#### Playground of Our Dreams



It all started as a dream two years ago and now it is a reality. Mrs. Klobucar and Mr. Wagner, teachers at H.W. Good

Elementary in the Yough School District, brought the idea to the principal, Dr. Larcinese.

They wanted to start an initiative to design a new playground that was safe and handicap accessible for all students. A playground committee was formed that consisted of teachers, parents, community members, business leaders and Sewickley Twp Supervisor, Alan Fossi and previous township supervisor, Wanda Layman. After two years of extensive fundraising and seeking out donations, almost \$31,000 was raised. The playground committee met with State Senator Ward and State Representative Harhai and they referenced the group to many state grant opportunities. A special partnership was formed between Yough School District and Sewickley Township to write a \$60,000 PA Greenways Grant, which we were fortunate enough to receive in July of 2016. Ground breaking on the new playground began in November, 2016. After three weeks the playground was complete. The students are excited to have the new structure and be able to interact with all students, regardless of ability. We are so excited to have this opportunity for our students of the Yough School District and the residents of Sewickley Township. As John Lennon said, "A dream you dream alone is only a dream. A dream you dream together is reality." Without the effort of so many people, this project would not have been possible. Thanks to everyone who made our dream come true!

#### Town Square

The intersection of Sewickley Avenue and Pike Street has been an eyesore for close to a decade. No longer — thanks to the Westmoreland County Land Bank and Sewickley Township, the dilapidated green house has been demolished. The Herminie Boy Scout Troop 259 and Sewickley Township partnered to create a lovely, peaceful area for residents to enjoy.

#### Sewickley Township Community Development Corporation

New to the township in 2016 was the creation of the Sewickley Township Community Development Corporation (STCDC) which is an entity specifically created to begin the process of revitalizing, reinvigorating and renewing the township.

One of the first orders of business that the new STCDC undertook was to conduct meetings with the Pennsylvania DCED and DCNR to make them aware of the new interest and efforts underway to bring improvements to Sewickley Township. In addition to making these introductions to the governmental entities which can assist us with our plans to revitalize the township, the STCDC will be looking for donations from businesses and residents, both in monetary and volunteer ways, to strengthen our efforts to achieve our goals of expanding community development and living conditions within our township.

The STCDC has already brought opportunities to the attention of the Recreation Board and Sewage Authority for ways that both of those entities can improve and expand their assets going forward. As 2017 begins, the STCDC will be focusing on projects and opportunities to begin planning for the cleanup and future revitalization of the business districts within the township. #### Sewickley Township Emergency Medical Services

Sewickley Township EMS had a very productive past year. The station located on 2 Medic Street. HERMINIE, had a considerable amount of inside remodeling performed. The lounge area received a new floor, walls, and ceiling. Painting of the living interior quarters was completed. Four new metal doors were installed by the crew from Shuster's Building Components. Thank You. Shuster's Building Components, for providing the financial support for the much needed doors. All remodeling was completed by personnel from Sewickley Township EMS. Sewickley Township EMS obtained a STATE grant and purchased a new hydraulic stretcher for patient movement. This coming year, plans to remodel the outside of the building will be discussed. A replacement ambulance for the 2003 unit has just been purchased and activated into our fleet.

Operationally, Sewickley Township EMS has again responded to over 2500 requests for service. The requests were for emergency and non-emergency responses as well as routine transports based on needs and approved by insurance groups.

The overdose epidemic has unfortunately involved township residents. The victims are cared for with NARCAN, the drug that has been used by EMS units nationwide. Some of the frustration that has developed is not being able to get to the overdosed victims to administer NARCAN in a timely manner. Other reasons of concern are when multiple overdose patients are in need of treatment at the same time because of the abundance of the laced drugs. There are times when taking care of an overdose incident interferes or delays in providing care to civilians with other emergency issues such as cardiac and respiratory problems. Nevertheless, we will obviously continue to provide service and care to all patients as promptly as possible. When necessary, there will be other medical services that will respond to provide pre-hospital care so all those who need EMS will be covered.

#### Sewickley Township Emergency Management

Sewickley Township Emergency Management uses a notification service called *Nixle* to improve communication with those who live, work, and visit our area. The system provides a quick, efficient, and secure way to get neighborhood-level information out to our community members who subscribe to the system. The department will be able to send text message and email alerts to subscribers in our area. Notifications might be considered in the following instances:

A young child or adult with Alzheimer's disease walks away from their home. The *Nixle* alert can include a picture of the child or adult with a map identifying the area in which they were last seen.

A public safety emergency requires people to stay in or remain away from their homes. A *Nixle* message can let residents with a registered address in the affected area know what is happening, allowing residents to take a proactive role in their own safety.

A serious injury or fatal crash in which traffic investigators close down the intersection for several hours during the morning commute. This situation might warrant a notification to subscribers who live or work in the area to select an alternative route.

Other use cases: Large-scale public works projects, Traffic mitigation, Community events such as parades, picnics or fundraisers, Utility outages Boil water orders.

Through *Nixle*, we will deliver messages securely to citizens by email and text message, supporting and expanding our community outreach efforts.



There is no doubt about it – storm water management in Pennsylvania is a multi-layered, multi-jurisdictional, ever-changing quagmire of rules, regulations and requirements. Township residents are often angered by the need to have the sewer lateral tested prior to the sale of property or the stringent storm water controls required for construction. It is hoped that this article will help residents understand why these requirements are in place. As you will see, these requirements are mandated by Federal and State laws.

#### What is the MS4 Program?

Untreated or uncontrolled storm water runoff is the number one cause of impairment in our local waterways. Polluted runoff is often transported through municipal drainage systems until it eventually discharges into streams, lakes, and rivers untreated. An MS4, or Municipal Separate Storm Sewer System, is comprised of drainage systems including streets, catch basins, curbs, gutters, ponds, ditches, man-made channels and storm pipes owned by a state, county, city, town, township, borough or other public entity. The National Pollutant Discharge Elimination System (NPDES) Storm Water Phase II regulations require a permit for storm water discharges from MS4s, mainly those located in urbanized areas. Therefore, most townships and boroughs, including Sewickley Township, are required to comply with the MS4 Program.

MS4 Programs are intended to improve our nation's surface waters by reducing the quantities of pollutants that are picked up by runoff and transported into the storm sewer systems during rainfall events. As part of the MS4 Program, municipalities must obtain a permit to discharge storm water into local waterways. This permit requires the municipalities to implement and maintain a storm water management program that (1) reduces the discharge of pollutants to the maximum extent possible; (2) protects water quality; and (3) satisfies the water quality requirements of the Federal Clean Water Act. In Pennsylvania, the MS4 program is administered by the Department of Environmental Protection (DEP).

The MS4 program has six elements termed "minimum control measures" that when implemented should result in significant reduction in pollutants discharged into receiving waters. The six minimum control measures and the actions required include the following:

- Public Education and Outreach Distribute educational materials and conduct outreach to inform citizens about the impacts that storm water runoff has on water quality.
- Public Participation/Involvement Provide opportunities for citizens to participate in the storm water management program or other programs which improve water quality.
- 3. **Illicit Discharge Detection and Elimination** Develop and implement a plan to detect and eliminate non storm water discharges into the storm water system.
- 4. **Construction Site Runoff Control** Develop, implement and enforce an erosion and sediment control program for construction site activities that disturb one acre or greater.
- 5. Post-Construction Runoff Control Develop, implement and enforce a program to address discharges of post-construction storm water runoff from new development or redevelopment areas.
- Pollution Prevention/Good Housekeeping Develop and implement a program that reduces or prevents pollutant runoff from municipal operations.

#### What can we do to help keep waterways clean?

There are numerous things we can all do on a daily basis to keep pollution out of our waterways. The following are just a few things we can all do to help improve water quality in our streams, rivers and lakes:

- 1. Never dump anything into storm drains, swales, or streams.
- 2. Pick up litter from the street before it gets into storm drains.
- 3. Use limited amounts of fertilizer.
- 4. If you must use pesticides, search for an environment-friendly brand.
- Recycle motor oil, paint, and other hazardous chemicals. Never dump such materials down the drain or into the storm system.
- 6. Recycle glass, plastic, and aluminum.
- 7. Always pick up your pet's waste or harmful bacteria can get into our water.

#### Storm Water (continued page 6)

All municipalities should be committed to improving water quality through better management of storm water runoff. Every resident can participate in their municipal storm water program by reducing or preventing pollutant runoff from their own property and by reporting any non-storm water discharges into the Township's drainage system.



#### What types of connections are prohibited?

The following connections are strictly prohibited:

- Any drainage pipe, channel or ditch, whether on the surface or subsurface, which allows non-storm
  water discharge, including sewage, process wastewater, and wash water, to enter the storm sewer
  system. and any connections to the storm drain system from indoor drains and sinks.
- Roof Drains Roof drains shall not be connected to streets, sanitary or storm sewers or roadside
  ditches, except when it is more advantageous to connect directly to streets or storm sewers.
   Connection of roof drains to street or roadside ditches may be permitted on a case-by-case basis.
   Roof drains shall discharge to infiltration areas or vegetative BMPs (Best Management Practices) to
  the maximum extent practical. This will help to promote groundwater recharge and reduce runoff.
- Waste disposal prohibitions It is illegal to dispose of or leave any refuse, rubbish, garbage, litter, or
  other discarded materials in any public or private property, driveway, parking area, street, alley,
  sidewalk or other component of the Township's storm sewer system so that such materials may
  cause or contribute to pollution. Garbage deposited in streets in proper waste receptacles for the
  purposes of routine collection is exempted from this prohibition.
- Any drain or pipe connected to the municipality's storm sewer system from a commercial or industrial land use which has not been documented in plans, maps, or equivalent records, and approved by the municipality.

The Sewickley Township Supervisors approved a three-year refuse hauling contract with Waste Management, Inc. beginning January 1, 2017. The supervisors awarded Waste Management the contract over Advanced Disposal Services, based on a system that allocated points to the low bidder in various categories – residential, senior citizens, seniors disposing of trash in Waste Management garbage bags, two cubic-yard containers and four-yard containers.

Garbage pickup is mandatory for residential property owners and commercial businesses in Sewickley Township. Every homeowner must have an account with Waste Management. Bills from Waste Management are mailed out quarterly.

 Single-Stream Recycling is available. The recycling bin is located at the back of the Sewickley Township Municipal Office Parking lot located at 2288 Mars Hill Road.
















