## **General Public Comment:**

Daryl Dermotta asked what the Treasurer's Bond is for. Mr. Petros explained that the bond protects the Township in case something happens and is mandatory. Mr. Dermotta then asked why the meeting time is changed. Mr. Petros explained that it is more convenient on the employees who attend the meeting. We used to have them at 3:00pm, but previous Supervisors could not attend them at that time. A lot of other Townships have their meetings in the afternoon. Mr. Dermotta then asked how County Hauling is working out. Mrs. Leukhardt stated that she is fielding a lot of calls, but no complaints on day two of the contract. County Hauling responds to every email sent to them and she is very happy with the repour she has with them. He then asked about the senior rate. Mrs. Leukhardt stated that if you are 65 or older, bring in proof of age and you can receive the senior rate of \$67.50 per quarter as opposed to \$75.00 per quarter.

Pat Knepp asked if the Township can post on social media without receiving comments. He suggests having a Facebook page to inform the community of updates in the Township but leave the comments off.

## New / Old Business:

Pat Knepp lives at 308 Shaner Road. When do you plan on doing something with Shaner Bridge? Mr. Petros stated that we have a new Public Works Director and today was his first day. We need to bring him up to speed. The previous Public Works Director had a list of things in motion. Mr. Knepp is split in wanting the bridge reopened or keeping it closed off. He has concerns about emergency vehicles needing to get in there, mud slides, a tree that looks like it can come down, etc. He was told that we will not be doing another bridge, but rather a corrugated pipe which will be much cheaper.

With no further business to come before the Board, Linda Harvey made a motion to adjourn, seconded by Mark Petros. Voting: Mr. Petros, Mrs. Harvey, Mr. Dull; yes. Meeting adjourned at 6:31pm.
