Brian Merdian asked when the last time was that any of the Board of Supervisors attended a SSMSA meeting. Mr. Petros stated he was there at the meeting earlier this month. How many people are we looking for to serve on the Board. Mr. Petros stated one (1) and there are no vacancies on the Sutersville side. Mr. Merdian hopes that there is a real effort to have those people on that Authority understand what needs to happen to rectify the problems. Help from the State, County, Federal cannot come in without the support of the Board of Supervisors and Sutersville Council. It starts at the local level. The other option is to vote to dissolve the SSMSA Board. Sewickley Board of Supervisors and Sutersville Council can then take over the Authority. Elizabeth Township did it and it worked for them.

General Public Comment

Nancy Bickus Neel introduced herself as a member of the SSMSA Board. They met on January 9, 2023 and gave a full account of that meeting. If the rate increase goes through, many families will have financial hardship. They don't want special treatment in their rates, but they do want to pay comparable sewage rates to the surrounding areas. Many will have their water shut off with a delinquent bill over \$200. Over 50% of the students in the Yough School District come from families that are considered to be financially stressed. At the SSMSA Reorganization meeting, she was named Treasurer and will recommend cost-cutting proposals, but that will still not be enough.

If SSMSA fails, it will be the responsibility of Sewickley Township and Sutersville taxpayers. She urges the Board of Supervisors to select a person for the sixth seat that will help make educated decisions to correct the problem. This is not a simple situation. The situation in Elizabeth is entirely different than what is going on here. We want to move forward, but we will need State or County help. Currently on the board, there is only one hold-over member. Every other member is a new member and is committed to work hard and make changes for this community.

Mr. Merdian responded about his time as Chairman of MSATS and on the Board of Supervisor. We saw and realized significant price increases. We convened meetings to provide a solution that worked. He agreed with most of what Ms. Bickus Neel stated but reiterated what he said earlier with what needs to happen. A conversation between the two continued.

Linda Coffer stated that they should have went in with Herminie and not Sutersville. This would not be an issue and we wouldn't be in this mess. With the milage money we get, why can't we apply for a grant to help us pull away from Elizabeth and put our pipeline either into Herminie's or make a new plant in Lowber. Mr. Petros stated that everyone wants to work toward a solution. The next step is coordinating a Townhall meeting where this all can be discussed. We need a plan in place before applying for funding.

Mr. Merdian then asked if there is a bond for the gas line work. Mr. Petros stated that we're still researching the amount with the gas company. Mr. Merdian then asked about the streetlights at the roundabout near the Rt 70 interchange. They're still not on. Mr. Petros will let him know something this week.

With no further business to come before the Board, Linda Harvey made a motion to adjourn, seconded by Mark Petros. Voting: Mr. Petros, Mrs. Harvey, Mr. Dull; yes. Meeting adjourned at 6:43pm.
