Voting: Mrs. Harvey, Mr. Petros, Mr. Merdian; yes. Motion carried unanimously.

Brian Merdian made a motion, seconded by Linda Harvey, to request proposals for court ordered clean-up of three (3) Costanza properties. Voting: Mrs. Harvey, Mr. Petros, Mr. Merdian; yes. Motion carried unanimously.

Brian Merdian made a motion, seconded by Linda Harvey, to authorize the Solicitor to file a protest/petition to intervene in the PAR MAR Oil Co. Liquor License transfer. Board Comments: Mr. Merdian clarified that the Township is basically doubling down on not supporting the transfer of a liquor license to the gas station. Mrs. Harvey stated the reason she voted no is because of the location being near the school and the playgrounds. Voting: Mrs. Harvey, Mr. Petros, Mr. Merdian; yes. Motion carried unanimously.

Brian Merdian made a motion, seconded by Linda Harvey, to hire Sydney Robertson as a Sewickley Township Recreation Intern at the rate of \$7.50 per hour. Voting: Mrs. Harvey, Mr. Petros, Mr. Merdian; yes. Motion carried unanimously.

Linda Harvey made a motion, seconded by Brian Merdian, to approve the sale of 2021 Season Passes at Crabapple Pool with the rates listed below.

## **General Public Comment**

Daryl Dermotta stated that Shaner Road needs fixed. Paul Hermann and Jim Fidei stated that there is hardly any pavement left on Shaner Road. Other roads were mentioned that need attention. Mrs. Harvey stated that there is a full page of roads and what needs done where that will be discussed during the Planning part of the meeting. Mr. Merdian stated that material prices keep going higher and we haven't raised General Fund taxes in a very long time. We need the Act 13 funds to supplement the highway maintenance supplies and salt.

Paul Hermann stated that he has been on the road crew for 27 years and this is the worse he has seen our roads. He understands that the storms over the past couple years have not helped. Mr. Petros stated that we're trying to figure out what we can do financially. We also need to finish the roads that were done by sealing them and putting in berms.

Jim Fidei stated that drainage needs to be addressed before paving. Circle Drive is one of them and was never finished. Volk also is in really bad shape. He then asked if the paving will be done inhouse or bid out. Mr. Petros stated that his thought would be for us to do the shorter, smaller roads.

Sam Slick is wondering why the Road Crew is spending over a week at the pool instead of working on the roads. Mr. Henderson stated that we lost the employee that helped open the pool so we had to do it until we hired someone.

Mr. Henderson stated that the purpose of the Planning Session is to select the roads that have the most need and then have the Engineer give us a recommendation on what specifically needs done to them. And then we decide if we will do the work or bid out. What can the Township afford to do this year? This list will continuously be updated year after year.
