An Executive Session was held on January 31, 2017 at 9:00am to discuss personnel matters.

### Report from Roadmaster, Joe Kerber

Since last month's meeting we have replaced all storm pipes on Slaughter Hollow Road. It is now open to all traffic. A storm pipe and catch box was replaced on Evans Street that was destroyed from the contractor when they put sewage in. A storm pipe was replaced on Shaner Hill Road and Shuglie Hill Road. The road crew was out four days doing cold patching. The road crew was called out eight times for plowing and salting. We've been working on keeping the storm drains opened from snow melting, heavy rains and all the trees and limbs falling from the wind storms. On January 24<sup>th</sup> I represented the Township in court. We used approximately 1100 tons of salt and approximately 1100 tons of anti-skid so far this winter.

### Report from Ordinance Officer, Bill Hause, given by Supervisor Brian Merdian

Since our last meeting I have been handling the usual complaints of junk motor vehicles around the township. I have been working with the state police and residents to correct these problems. I have been in contact with the nuisance property owners in the township, which whom I've sent letters to, and most of them are making progress with their issues. Research is being done on a problem property in Lowber and hopefully we can get the owners to cooperate and bring this property into compliance. Please remember when parking to leave room for the snow plows. I've had to tag several vehicles throughout the township because the plows could not get through the roadways.

Mr. Kerber stated we will have to look into getting permission from you to come on private property. Mr. Stafford stated that I will grant you that permission.

John Seanor commented on the new rates for garbage service. He asked why couldn't take a list of all the delinquents and make them public knowledge. We do it for taxes and other things. Why should I have to pay for the people who don't pay? Mr. Merdian stated that this is something we can look into legally and see if this is something we could do. Mr. Seanor stated that it might bring some attention to those not paying and maybe we could then bring some of that delinquent money in. A resident asked about the senior citizen rates and how they are so high. They asked if there is any way we could negotiate. Mr. Merdian stated that we put this up for bid. The bids came in in a competitive way. If you look at the guy that was bidding second, you would have to add another eight dollars to these rates.

Lori Jones had a question on the motion to use Act 13, Impact funds on rock salt. Since Act 13 is not in the budget, how would we know what you are spending it on? Mr. Merdian stated that purchasing rock salt is one of the thirteen things allowed to be purchased by Impact Funds. Act 13 money is categorized outside of the general fund budget. This is why it is on the agenda. It is not for general use and we categorized it as it's supposed to be.

A resident stated that some of our guys didn't get home in till 6:30 am the next morning.

Mrs. Jones wanted to be clear on having alcohol at Community Days. She stated that they will have their own insurance. Mr. Merdian stated that we will not permit the sale of alcohol on Township property at all.

Mr. Balog asked what the process is when someone files an appeal and when was he to be notified? Mr. Merdian stated that the next step is to have Mike Stack go out to investigate the property, and report back to the Zoning Board. If a hearing is needed we will notify you.
