

CRABAPPLE POOL RULES

ADMISSION POLICIES

- THERE IS ABSOLUTELY NO READMISSION FOR NON-PASSHOLDERS.
- CRABAPPLE POOL RESERVES THE RIGHT TO CLOSE FOR LACK OF ATTENDANCE, TEMPERATURE (72 DEGREES AND LOWER), AND INCLEMENT WEATHER CONDITIONS. THIS IS DETERMINED BY MANAGEMENT AND THE TOWNSHIP.
- RAINCHECKS WILL ONLY BE ISSUED IF CRABAPPLE POOL CLOSES.
- CHILDREN **UNDER 13 YEARS** OF AGE MUST BE ACCOMPANIED BY AN ADULT.
- CHILDREN 5 YEARS AND UNDER MUST BE WITH A PARENT/GUARDIAN AT ALL TIMES. PARENTS/GUARDIANS MUST BE WITHIN ARMS REACH OF THEIR CHILD AT ALL TIMES. DO NOT LEAVE YOUR CHILD UNATTENDED.
- ABSOLUTELY NO STREET CLOTHES ARE ALLOWED IN THE POOL.
- ONLY SNUG FITTED, **HIGH COLLAR** RASH GUARD SHIRTS ARE PERMITTED. THE ALLOWED FIT OF RASH GUARD SHIRTS WILL BE DETERMINED BY THE POOL MANAGER OR LIFEGUARDS.
- SWIM DIAPERS ARE REQUIRED FOR ALL CHILDREN NOT POTTY TRAINED.
- ONLY **SMALL LUNCH-SIZE COOLERS** ARE PERMITTED. NO LARGE WHEELED COOLERS ALLOWED.
- OUTSIDE FOOD DELIVERY IS STRICTLY PROHIBITED TO THE POOL OR PARK.
- NO ALCOHOLIC BEVERAGES ARE PERMITTED IN CRABAPPLE POOL OR PARK.
- NO GLASS CONTAINERS OF ANY KIND ARE PERMITTED IN THE FACILITY.
- ALL LOUNGE CHAIRS/CHAIRS MUST BE KEPT A **MINIMUM OF 10 FEET AWAY** FROM THE POOL AREA.
- ALL STROLLERS, CHAIRS, TENTS, AND TOWELS MUST BE KEPT CLEAR FROM ALL HIGH TRAFFIC AREAS.
- PROFANITY, SQUIRTING, OR HARASSING OTHER PATRONS WILL NOT BE TOLERATED.
- EXCESSIVE PUBLIC DISPLAYS OF AFFECTION WILL NOT BE TOLERATED.
- MANAGEMENT MAY REFUSE ADMITTANCE TO ANYONE WHO APPEARS TO BE UNDER THE INFLUENCE OF DRUGS OR ALCOHOL.
- LIFEGUARDS RESERVE THE RIGHT TO DETERMINE "PROPER" CONDUCT FOR ALL PERSONS IN THE FACILITY. BLATANT DISRESPECT AND/OR DISREGARD TO THE LIFEGUARDS' INSTRUCTIONS IS GROUNDS FOR IMMEDIATE DISMISSAL FROM THE FACILITY.

CHILDREN OVER THE AGE OF 5 IN THE BABY POOL	CHILDREN 5 AND UNDER ACCOMPANIED BY AN ADULT
The Pool Manager and Lifeguards have the right to remove any child over 5 years of age from the Baby Pool. This is determined by the number of children in the Baby Pool and if they are interfering with the safety or play of younger children.	
LOUNGE CHAIRS, STROLLERS, BLANKETS, CHAIRS, TOWELS, OR TENTS IN HIGH TRAFFIC AREAS AROUND THE POOL. THESE ITEMS (BY LAW) MUST BE KEPT 10 FEET FROM THE POOL.	LOUNGE CHAIRS, STROLLERS, BLANKETS, CHAIRS, TOWELS, OR TENTS IN THE GRASSY AREAS AROUND THE POOL. THESE ITEMS (BY LAW) MUST BE KEPT 10 FEET FROM THE POOL.

EXAMPLES OF WELL FITTED HIGH COLLAR RASH GUARD SHIRTS **ALLOWED** AT CRABAPPLE POOL. DO NOT BUY RASH GUARD SHIRTS THAT FIT LOOSELY, THEY WILL NOT BE PERMITTED.



EXAMPLES OF COAST GUARD APPROVED LIFE VESTS **ALLOWED** AT CRABAPPLE POOL. **VESTS THAT DO NOT BUCKLE BETWEEN THE LEGS ARE NOT PERMITTED.** THESE ITEMS ARE **NOT ALLOWED** TO BE WORN OFF THE DIVING BOARD OR DOWN THE SLIDE.



EXAMPLES OF ARM SWIMMIES/FLOATIES ALLOWED AT CRABAPPLE POOL. THESE ITEMS ARE **NOT ALLOWED** TO BE WORN OFF THE DIVING BOARD OR DOWN THE SLIDE.



THE FOLLOWING ARE EXAMPLES OF FLOTATION DEVICES THAT **ARE NOT ALLOWED, UNDER ANY CIRCUMSTANCE**, IN CRABAPPLE POOL!



RULES AND REGULATIONS

DIVING BOARD

NOT PERMITTED

ANYONE UNABLE TO SWIM UNASSISTED TO THE LADDER OR OUT OF THE DIVING BOARD AREA

PROFICIENT SWIMMERS ONLY

MORE THAN ONE PERSON AT A TIME OFF THE DIVE

ONE PERSON AT A TIME OFF THE SLIDE

SWIM VESTS OR ARM SWIMMIES ON THE DIVING BOARD

GOGGLES WORN OFF THE DIVE

GOGGLES WORN IN THE GENERAL POOL AREAS

DIVING IN SHALLOW WATERS

DIVING OFF THE DIVING BOARD DIRECTLY TO THE LADDER

DOUBLE BOUNCING THE DIVING BOARDS

DIVING OFF THE DIVING BOARD AND SWIMMING STRAIGHT UNDER THE ROPES AND OUT OF THE DIVING AREA.

CATCHING CHILDREN FROM THE DIVING BOARD

FORWARD FACING ACTIVITIES ONLY.

HANGING ON THE DIVING BOARDS

BACK DIVES, BACKFLIPS, OR GAINERS

SWIMMING IN THE DIVING AREA

THROWING OR CATCHING BALLS OR TOYS WHILE IN THE DIVING BOARD AREA OR ON THE BOARD

SITTING AROUND THE DIVING BOARD AREA

HORSEPLAY ON OR AROUND THE DIVING AREA

THE LIFEGUARDS RESERVE THE RIGHT TO DETERMINE IF YOU OR YOUR CHILD IS GETTING TIRED AND NEEDS TO TAKE A REST FROM THE DIVING BOARD.

RULES AND REGULATIONS

WATER SLIDE

NOT PERMITTED

PERMITTED

ANYONE UNDER 48" TALL, NO EXCEPTIONS

LIFEGUARDS & MANAGEMENT RESERVE THE RIGHT TO MEASURE ALL CHILDREN BEFORE RIDING THE SLIDE

BACKWARD, STOMACH, OR HEAD FIRST SLIDING

ONE SLIDER AT A TIME

CATCHING CHILDREN COMING DOWN THE SLIDE

FORWARD FACING WITH FEET FIRST SLIDING, NO EXCEPTIONS

PARENTS/PATRONS INSIDE THE SLIDE ZONE AT ANY TIME

SWIMMING IN THE SLIDE ZONE

SWIMMING DIRECTLY OUT OF THE SLIDE ZONE

LIFE VESTS, ARM SWIMMIES, OR GOGGLES DOWN THE SLIDE

BALLS OR TOYS IN THE SLIDE ZONE

THROWING BALLS OR TOYS IN THE SLIDE ZONE

HANGING ON OR AROUND THE BUOYS OR ROPES

HANGING ON THE LADDER

WAITING AT THE BOTTOM OF THE LADDER UNTIL THE SLIDER IN FRONT OF YOU IS COMPLETELY OUT OF THE SLIDE ZONE

HORSEPLAY ON OR AROUND THE SLIDE OR IN THE SLIDE ZONE

ANYONE OVER 275 LBS.

RULES AND REGULATIONS

SAND VOLLEY BALL COURT

NOT PERMITTED

PERMITTED

THROWING THE BALL OUTSIDE THE COURT

SIGN OUT THE VOLLEYBALL AT THE CONCESSION STAND

HANGING ON, ADJUSTING, OR MODIFYING THE NET

SHOWERING BEFORE ENTERING THE POOL AREA IS A MUST

DIGGING HOLES OR BUILDING SANDCASTLES

PLEASE RETURN THE BALL TO THE CONCESSION STAND

BURYING PEOPLE OR OBJECTS IN THE SAND

HAVE FUN AND ENJOY THE COURT

FOOD OR BEVERAGES ON THE COURT, THIS ATTRACTS BEES

ACTIVITIES OTHER THAN VOLLEYBALL

PLAYING ON THE COURT WHEN A GAME IS IN SESSION

NOT SHOWERING BEFORE ENTERING THE POOL AREAS

GAMES LONGER THAN 30 MINUTES WHEN OTHERS ARE
WAITING TO PLAY

FOR YOUR SAFETY, THIS IS NOT A SAND BOX IT IS FIRST AND FOREMOST A VOLLEYBALL COURT

RULES AND REGULATIONS

STORM POLICY

BY LAW, THE POOL MUST BE CLEARED IF THUNDER OR LIGHTNING OCCURS.

BY LAW, THE POOL MUST BE CLEARED FOR 30 MINUTES FROM EACH OCCURANCE OF THUNDER OR LIGHTNING.

IF PATRONS CHOOSE TO STAY, ALL PATRONS MUST RELOCATE TO UNDER THE PAVILION.

IF WEATHER CONDITIONS BECOME DANGEROUS, ALL PATRONS MUST TAKE SHELTER IN THE BATHROOMS. THIS WILL BE DETERMINED BY POOL MANAGEMENT.

IF YOU CHOOSE NOT TO TAKE SHELTER IN THE BATHROOMS, YOU MUST LEAVE CRABAPPLE PROPERTY IMMEDIATELY.

IF THERE IS HEAVY RAIN AND THE BOTTOM OF THE POOL IS NOT VISIBLE, THE POOL MUST BE CLEARED.

CRABAPPLE POOL RESERVES THE RIGHT TO CLOSE FOR LACK OF ATTENDANCE, TEMPERATURE (73 DEGREES AND LOWER), AND INCLEMENT WEATHER CONDITIONS. THIS IS DETERMINED BY MANAGEMENT AND THE TOWNSHIP.

RAINCHECKS WILL ONLY BE ISSUED IF CRABAPPLE POOL CLOSES.

PLEASE NOTE THAT ANY CHILD AGED 13 AND OVER, **THAT IS NOT ACCOMPANIED BY AN ADULT**, MUST HAVE TRANSPORTATION FROM THE FACILITY **NO MORE THAN 30 MINUTES** FROM THE POOL CLOSURE ANNOUNCEMENT. THE POOL **WILL NOT STAY OPEN MORE THAN 30 MINUTES** FROM THE TIME OF THE ANNOUNCEMENT. YOUR CHILD WILL BE ABLE TO CALL YOU FROM THE FACILITY IF NECESSARY. IT IS THE PARENTS/GUARDIANS RESPONSIBILITY, WHEN DROPPING OFF YOUR CHILDREN WITHOUT ADULT SUPERVISION, TO HAVE THIS TRANSPORTATION AVAILABLE FOR YOUR CHILD.
